



Grantmaker support for grantee capacity-building activities includes:




91% support governance or leadership capacity




81% support financial capacity

Native wildlife thrive throughout networks of connected lands and waters in western North America.









SUPPORT NONPROFIT RESILIENCE

The size of many grants, and the strings attached to them, often don't align with the results grantmakers seek.
